### State Compliance Regulations

**Alaska:** 2 cases per shipment, 12 cases per individual, per calendar year

**Alabama:** 12 cases per person, per year; ABC stores prohibited

**Arizona:** 12 cases per person, per year

**Arkansas:** 1 case per person, per quarter; on-site sales permitted to ship only/off-site sales prohibited

**California:** Unlimited

**Colorado:** Unlimited

**Connecticut:** 25 bottles per person, every 62 days

**District of Columbia:** 1 case per person, per month

**Delaware:** Unlimited; on-site sales permitted to ship only/off-site sales prohibited

**Florida:** Unlimited; dry counties, 3L/6L bottles prohibited

**Georgia:** 12 cases per household, per year for offsite sales; on-site sales 5 case maximum

**Hawaii:** 6 cases per household, per year

**Idaho:** 24 cases per person, per year

**Illinois:** 12 cases per person, per year

**Indiana:** 24 cases per person, per year

**Iowa:** Unlimited Kansas: 12 cases per household, per year

**Kentucky:** 10 cases per person, per month

**Louisiana:** 12 cases per person per year; 6L bottles prohibited; excludes wines in distribution

**Massachusetts:** 12 cases per person, per year

**Maryland:** 18 cases per household, per year

**Maine:** 12 cases per household, per year

**Michigan:** Unlimited; Copy of driver's license required if unverifiable birthdate

**Minnesota:** 2 cases per person, per year

**Missouri:** 2 cases per person per month

**Montana:** 18 cases per person, per year; not to exceed 16% alcohol

**Nebraska:** 12 cases per person, per year

**Nevada:** 12 cases per person, per fiscal year (beginning July 1)

**New Hampshire:** 12 cases per person, per year

**New Mexico:** 2 cases per person per month

**New York:** 36 cases per person, per year

**North Carolina:** 2 cases per person, per month

**North Dakota:** 3 cases per person, per month

**Ohio:** 24 cases per household, per year

**Oklahoma:** 6 cases per person per year; winery shipping only

**Oregon:** 5 cases per person, per month

**Pennsylvania:** 36 cases per individual, per year

**Rhode Island:** Unlimited; on-site sales permitted to ship only/off-site sales prohibited

**South Carolina:** 2 cases per person per month; not to exceed 16.5% alcohol

**South Dakota:** 12 cases per person, per year

**Tennessee:** 1 case per person, per month; not to exceed 3 cases per person per year

**Texas:** 45 bottles per person, per month; not to exceed 15 cases per person per year

**Vermont:** 12 cases per person, per year; not to exceed 16% alcohol

**Virginia:** 2 cases per person, per month

**Washington:** Unlimited

**West Virginia:** 2 cases per person, per month

**Wisconsin:** 12 cases per person, per year

**Wyoming:** 12 cases per person, per year

**States prohibited for direct shipping:** New Jersey, Mississippi, and Utah
